How does Raiz FCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files.	
	 Required passwords for access to your accounts via remote delivery channels, (confidentiality of these passwords are your responsibility) and Encryption & security measures such as multifactor authentication 	
How does Raiz FCU collect my personal information?	We collect your personal information, for example, when you open an account or deposit money make loan payments or apply for a loan use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes – information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account, unless you tell us otherwise.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	■ Raiz FCU does not share with our affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies.	
	■ Nonaffiliates we share with can include mortgage companies, title companies, insurance companies, direct marketing companies, and nonprofit organizations.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.	
	■ Our joint marketing partners include insurance companies & direct marketing companies.	

Other important information

If you are a California resident, California state law gives you additional rights to limit information sharing even if such sharing is otherwise permitted under federal law. With respect to California residents Raiz Federal Credit Union allows you to limit our sharing your personal information under a joint marketing agreement with joint marketing partners.

If you are a California resident we have enclosed a form entitled "Important Privacy Choices for Consumers" which includes details on how you can limit our information sharing under California law.
